

#### FREE TRADE ZONE

The Free Trade Zone regime (RFE in Spanish) allows foreign, domestic or already imported goods to be destined to an approved warehouse (fiscal depot), to be stored, exhibited, sold or distributed.

#### outdoor storage

100,000 m<sup>2</sup> (1,000,000 ft<sup>2</sup>) square meters of outdoor storage space

## Our services

## cross-dock

Notice of arrival of shipments so that they are immediately collected.



## truck cargo handling

All merchandise can be loaded/unloaded to all sorts of vehicles.

## deconsolidation

Goods that arrive in our facilities can be deconsolidated to use or deliver a fraction of the arrived goods.



#### storage

Storage area both indoors or outdoors, using bonded warehousing services or not.

## rail cargo handling

With over 2 Km (1.3 mi) of rail spur we can unload intermodal or general cargo.





#### bonded warehouse

Merchandise can be stored deferring VAT or import tariffs payment (up to 24 months).





# Free Trade Zone (FTZ) advantages



#### deferred taxes

Upon importation, any tax, duty or countervailing duty is deferred. Payment occurs only **when** and **if** the goods are introduced to the local market.



#### time reduction

Introduction of goods through the RFE regime can expedite the import and export process.



#### avoid non-tariff restrictions

Non-tariff restrictions compliment are deferred until the import of merchandise



#### long time frame

Goods can remain up to 24 months (2 years) in the RFE regime.





# Free Trade Zone (FTZ) advantages



#### regime flexibility

Goods can later be destined to the following regimes:

- Definite import / export
- Return overseas
- Transfer to another program (IMMEX)



#### optimized deconsolidation

Imported goods stored in the FTZ may de deconsolidated to optimize tax benefits by legally "importing" as the need for the product arises.



#### **IMMEX** benefits

IMMEX products can be sent into FTZ and will be considered exported




# Import process

Origin

The merchandise is shipped from origin



#### Mexican Port or Border

Merchandise enters to Mexico

They aren't thoroughly examined by the authorities or required to pay taxes or duties.









At the port of entry, FTZ import document is made, for transport of goods from port to warehouse.

Merchandise is shipped to FTZ




**FTZ** entry

Goods can be selected as required by client, Client can select merchandise from different containers Part of the container can be left in storage in the RFE






#### **Client** Import Document

Client makes definitive import document. Pays VAT, import taxes and duties.




